

Snapshots from the 2022 Afroeuropean conference

On 22-24 September, VUB hosted the 2022 Afroeuropeans Conference, partnered by BIRMM. This 2022 edition of the Afroeuropeans Conference set up by the Afroeuropeans Network focused on "Intersectional Challenges in Afroeuropean Communities" in Brussels as an academic, activist, and intellectual space. It centered Blackness in Europe—including Black identity, Black art, Black politics and Black struggle.

In the course of three full days, the conference provided a platform to over 200 speakers and participants, no fewer than 38 panels and roundtables took place across 8 thematic streams, in addition to 3 evening programmes and 3 distinguished keynote lectures. The keynote speakers were Olivette Otele, Kehinde Andrews and Mireille-Tsheusi Robert. The VUB BIRMM Team supported the organizational committee in the co-organization of the conference and several BIRMM members also participated as speakers or panel chairs.

BIRMM research seminar with Laura Westerveen and Louise Hantson!

On October, Laura Westerveen and Louise Hantson will present preliminary findings from the Whole-COMM project. Whole-COMM is a Europe 2020 Horizon project that explores the integration of post-2014 migrants in small and medium-sized towns and rural areas. The project studies the integration of these migrants Whole-of-Community through a perspective. The latter considers migrant integration as an open-ended process that involves interactions between multiple actors. They include citizens, long-term residents, and newly arrived migrants as well as state, market and civil society actors. In the presentation, the main findings of the ongoing Whole-COMM project will be presented, focusing on four small to medium-sized towns in Belgium (two in Flanders and two in

These young people give insights into their daily environment in Brussels that are very different from one another. Participatory documentary 'Paper Borders'

In the context of the doctoral research of BIRMM member <u>Marijke Van Buggenhout</u>, a participatory documentary was realized by a group of young newcomers.

Paper Borders shows how a group of young newcomers decided to make a film together. They undertook a symbolic journey to the sea; a journey that leads to stories about their flight, their arrival in a new country, and their grueling asylum procedure. Paper Borders takes the viewer into the world of these teenagers and shows how they struggle with the uncertainty about their future, continuously oscillating between happiness, hope and despair.

These young people got to work with the camera themselves and worked on the stories and their film adaptation in co-creation with Marijke Van Buggenhout and filmmaker Marjolijn Prins. On June 23, 2022, they introduced the film to their entourage. At that presentation at VZW Cinemaximiliaan, the project received the Lydia Chagoll Prize 'For a child's smile' from the King Baudouin Foundation.

The next screening of the film is scheduled for an afternoon study on asylum and children's rights on 6 December (in Dutch). This afternoon is organized for criminology students, but is also open to other interested parties.
