

"Deporting Children. Policy framing, legitimization and intersectional boundary work"  
by Laura Cleton**

Join us on our next BIRMM seminar with [Laura Cleton](#) on 9 January! Deporting non-citizens is widely perceived as an inseparable part of nation states' right to control their borders and to determine who can become part of their community of members. This right is complicated, however, by illegalized children's claims to belonging, the overarching children's rights regime, and the imaginary of children's innocence. In this seminar, Laura Cleton will draw on findings from her dissertation research that investigated how states that seek to deport children, in the face of such disputes, legitimize the need to do so to themselves and to the wider citizenry. 

### Film: Een Geschiedenis



Hun ervaringen en de werking van de verschillende centra worden vanuit een criminologisch-penologische invalshoek bestudeerd op basis van langdurige observaties, talrijke informele gesprekken en interviews. ## Elieze Termote

Elieze Termote (criminology/law) conducts research in the two new Belgian prisons, Haren and Dendermonde, as project coordinator. This research departs from the diverse needs of incarcerated people, to set up experiments and better align practice in prison with these needs.



## Elias Woodbridge

Elias is a PhD researcher at both the Department of Political Science and the Department of Criminology at the VUB. Building up to this doctorate study, Elias researched the racialisation of Muslim men living in Flanders which was conducted during his master Gender and Diversity.





## Christophe Snoeck

Christophe Snoeck is a Research Professor at the Vrije Universiteit Brussel, and the head of the Brussels Bioarchaeology Lab ([www.BB-LAB.be](http://www.BB-LAB.be)). In his research, he combines multi-disciplinary expertise in archaeology and isotope geochemistry to answer key archaeological questions, amongst others on the migration of populations. He is also the PI of the ERC starting grant LUMIERE ([www.erclumiere.be](http://www.erclumiere.be)) looking at mobility and landscape use across Europe from the Neolithic to the Middle Ages.



## Valérieane Mistiaen

Valérieane Mistiaen is a ULB-VUB PhD candidate in communication sciences. At VUB she is affiliated to the [ECHO research centre](#). She was a researcher involved in the IM2MEDIATE project (funded by Belspo) studying the representation of migrants in Belgian and Swedish media. She is also a member of the Center for Research in Information and Communication Sciences ([ReSIC](#)). Her PhD research focuses on the denomination of people on the move in Belgian French-speaking and Dutch-speaking media since the beginning of the so-called refugee crisis in April 2015.



## Koen Kerremans

Koen Kerremans is a professor of terminology and translation technology within the Department of Linguistics and Literary Studies (LIST) of the Faculty of Languages and Humanities. His primary research interests lie in the study of terminology and specialised language, on the one hand, and the use of digital

translation resources and tools in professional and educational settings, on the other hand. His research also focuses on different types of language assistance for third-country nationals and newcomers.
