



Gaia Romeo on the EU's shift toward an '(un)safe fourth country' asylum policy in The Loop

In a recent blogpost for *The Loop* (ECPR Blog), BIRMM member <u>Gaia Romeo</u> and co-author <u>Frowin Rausis</u> analyse the European Commission's proposal to remove the 'connection requirement' from the safe third country concept. They argue this technical change marks a profound political shift: opening the door to an '(un)safe fourth country' approach that risks undermining refugee protection and repeating the failures of past externalisation attempts. VUB journalism students on wrongful detention of international students in Belgium for Knack

A new investigation by journalism students at VUB documents how at least six non-EU students were wrongly held in Belgian closed detention centres over the past two years despite valid visas. Through first-person accounts, the piece details harsh conditions, due-process gaps at the border, and lasting mental-health impacts. Experts and universities highlight systemic issues such as unclear procedures, language barriers, and limited safeguards while calls emerge for clearer legislation and better expertise at
